## Introducing Mobile Check Deposit

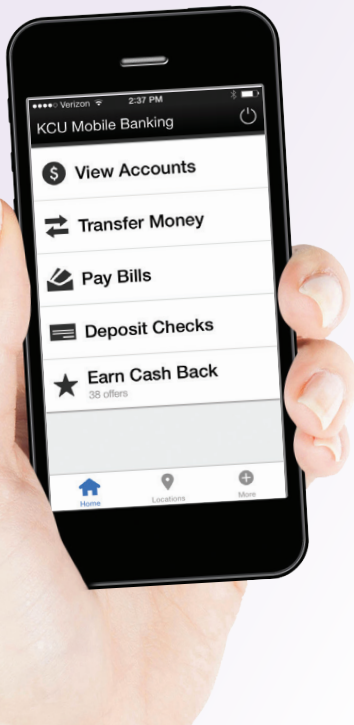
The solution that makes your life easier just got better! You can now deposit checks using Kitsap Credit Union's Mobile Banking App and your mobile device's camera function.

No matter where you are, no matter what time of day – it's simple, secure, and quick to deposit your checks.

Deposits are generally credited to your account the same day, and the app is easy – walking you through the process step-by-step. You'll also receive email confirmation for added peace of mind.

### Here's how it works:

- 1 Be sure you have updated the KCU mobile app recently.
- 2 Login to your mobile app.
- 3 Tap "Deposit Checks."
- 4 Accept the Mobile Deposit agreement. (You'll only need to complete this step the first time you use the Mobile Deposit feature).
- 5 Select into which account you want the funds deposited.
- 6 Type in the dollar amount of the check.
- 7 Endorse the back of the check with "For KCU Mobile Deposit Only", your signature and account number.
- 8 Take a photo of the front and back of the check.
- 9 Click "Deposit", and you're done.



Next time you receive a paper check, save yourself some time and skip a trip to the branch or ATM – rely on our mobile app instead.

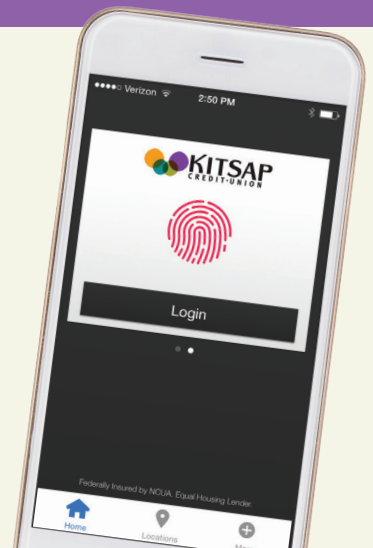
## Mobile App Now Enabled For Touch ID™

Touch ID™ is the name of Apple's biometric fingerprint authentication technology. If you have an iPhone® 5s, 6, or 6 Plus, you can enable this feature on your phone as a highly secure alternative to using a passcode or strong password to access your phone and certain apps.

KCU's mobile app is now enabled for the Touch ID™ feature, which means you can log in to mobile banking with your fingerprint. And, look for iPad® Touch ID support later this year.

**3** Once their account is open we'll deposit \$33 to each of you and send your local animal shelter \$34.

An eligible referral requires a current member and a new member. New members must be 18 years of age and meet Credit Union membership eligibility and account opening requirements. APY refers to Annual Percentage Yield. Regular Savings APY is .01%. Minimum to open a savings account is \$5.00 and a minimum average daily balance of \$25.00 is required to earn the APY. Gold Checking APY is 1.50%. Minimum to open a Gold Checking account is \$25.00. No minimum balance required to earn the APY. Rates are current as of June 1, 2015 and are subject to change. Offer is for a limited time only. \$33 bonus deposited at account opening. \$34 Donations will accrue and be divided between Center Valley Animal Rescue of Jefferson County, Kitsap Humane Society, the Prison Pet Partnership of Gig Harbor, and Mason County's Sunrise Equine Rescue after August 15, 2015.
